

## NOTICE OF EFFECTIVE TAX RATE

### 2007 PROPERTY TAX RATES IN HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 11

This Notice concerns 2007 property tax rates for **Harris County Emergency Services District No. 11**. It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's *effective* tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's *rollback* tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

= This year's effective tax rate (Maximum rate unless unit publishes notices and holds hearings)	\$	.02895/\$100

**This year's rollback tax rate:**

Last year's adjusted operating taxes (after subtracting taxes on lost property and adjusting for transferred function, tax increment financing, and/or enhanced indigent health care expenditures)	\$	7,137,479.00
÷ This year's adjusted tax base	\$	24,654,082,967.00
= This year's effective operating rate	\$	.02895/\$100
x 1.08 = this year's maximum operating rate	\$	.03126/\$100
+ This year's debt rate	\$	-0-
= This year's rollback rate	\$	.03126/\$100

**Statement of Increase/Decrease**

If Harris County Emergency Services District No. 11 adopts a 2007 tax rate equal to the effective tax rate of \$.02895 per \$100 of value, taxes would increase compared to 2006 taxes by \$448,381.00.
